2. Opening Remark, 19h30: S. Uyeda: Chair

Seiya Uyeda opened the meeting and welcomed all participants. He thanked all for their active participation in the four EMSEV sessions held at IUGG. Due to limited time, he recommended proceeding as quickly as possible with the EMSEV meeting business.

3. Reports from liaison officers:

Jacques Zlotnicki (IAGA liaison) pointed out that IAGA continues to provide support for the EMSEV WG when our studies are based on clear pre-, co- and post-observations to earthquakes and volcanic eruptions, physics of processes, etc.

Malcolm Johnston (IASPEI, IAVCEI liaison) outlined the role of EMSEV in IASPEI and IAVCEI. Within these organizations (and the IUGG), our only role is to provide a forum for discussion of electromagnetic effects expected and observed with earthquakes and volcanoes. It is therefore extremely important that participants in meeting run by EMSEV do not make public announcement regarding earthquake prediction in the name of EMSEV. EMSEV has no authority to support such statements.

The general discussion reiterated the clear understanding that papers dealing with prediction are the responsibility of the authors, not of the EMSEV WG.

4. Report of EMSEV activity in 2006- Perugia 2007: Nagao: Secretary

4.1 Web site

Toshiyasu Nagao (EMSEV Secretary) outlined the history and structure of EMSEV Web site:

- Electromagnetic fields associated with earthquakes and active faulting (JSS008) (Main convener M. Johnston)
- Seismo-electromagnetic studies using space technology (JSS010) (Main convener R.P. Singh)
- Volcanic structure and activities (JSS007, JVS002) (Main convener: S. Spichak)

More than 143 abstracts were accepted and presented in the four sessions.

6. EMSEV Structure

- The **EMSEV members**. There are 35 members (14 countries) with generally not more than five per country to ensure international and interdisciplinary balance.
- The **EMSEV corresponding members,** about 220 in number, include all (i.e., any number per county) who are interested in EM aspects of earthquakes and volcanoes and have joined the EMSEV mailing list.

IUGG has asked to EMSEV to nominate a new chair. The Bureau nominated Jacques Zlotnicki to next Chair and Malcolm Johnston to Vice Chair. Seiya Uyeda will be Past Chair.

Professors P. Varotsos, D. Stanica and R.P. Singh asked Seiya Uyeda again to chair EMSEV WG for several more years. S. Uyeda responded that he has now done this for almost 8 years and declined with thanks. A general vote validated the new Chair and Co-Chair.

10. Publication policy for Perugia Sessions.

IASPEI President Engdahl encourages special volumes in Elsevier journals to Lead Conveners of IUGG 2007 IASPEI-Led Symposia & Workshops

From: Bob Engdahl, IASPEI President Subject: Publication of Proceedings

As at previous assemblies, you should consider publication of the Proceedings of your Symposium or Workshop in Elsevier journals such as Physics of the Earth and Planetary Interiors or Tectonophysics. In return for royalties that are used to support Association activities and participation in General Assemblies, IASPEI has given Elsevier the right of first refusal. There needs to be developed a package of "thematic" special volumes relevant to those journals (e.g., structure, tectonics, etc.) for submission to Elsevier as a publications proposal. Information required in such a proposal follows:

- (1) A tentative list of manuscripts, for which the authors have, in principle, indicated that they are willing to contribute to such a project. The primary requirement is scientific quality. Nevertheless, it should be noted that the list of papers should represent a coherent set which are clearly linked by an overall theme, with international appeal.
- (2) Details of the team of Guest Editors (preferably an international team of 2-3 specialists in the field, preferably with editorial experience, and one of whom should have English as their first language).
- (3) Details of the time schedule for completion of the project.

Now that the final program of IASPEI-led symposia and workshops has been put together we should begin the process of developing an IASPEI publication package. Please contact the IASPEI Secretary General (Peter Suhadolc) with suggestions or questions you may have about your publication options...

It appears to our community that a large volume including the contents of our four sessions should be more appropriate if a link is done between the topics. Lead convener of each session should contact the authors to evaluate the number of potential papers.
